TERMS AND CONDITIONS

- Fuel surcharge may be applicable;
- Prices valid in the specified region only;
- Maintenance service includes pumping, cleaning, replenishing supplies, and unit inspection;
- Displacement costs, winterization, frozen toilets and resumption of services will be billed, if necessary;
- Offer valid for 30 days following the delivery date and contingent on the availability of the equipment;
- Prices subject to change without prior notice;
- Terms of payment: Net 30 days, on approved credit, 12% annual interest rate on the outstanding balance.

THE CUSTOMER AGREES TO

- Upon delivery, the customer must verify and approve the condition of the sanitary unit and immediately inform Sanivac of any defect. The customer must also understand the unit's proper usage once delivered.

 Assure proper access at ground levels for the sanitary units to secure a proper service. Any delay exceeding 10 minutes for carrying out services done by Sanivac will be billed. In cases where Sanivac would encounter difficulties carrying out the services set herein as a result of customer negligence, Sanivac shall in no way be liable for damages incurred. In cases where the services cannot wait for the next planned visit, resumption service fees will be charged.
- Plug units correctly and according to instruction and supply electricity at all times during cold periods to prevent any freezing and/or breakage.

 Acquire any permit, licence or authorizations required, and notably the site layout, and pay the costs related thereto.

 Maintain units in a proper sanitary state by adjusting the number of units or services necessary according to the site needs.

 Maintain exclusive and absolute control over the sanitary units and return them to Sanivac at the end of the usage period.

 Abstain from making any modification to the sanitary units without prior written approval from Sanivac.

- Limit the unit usage to human waste elimination only
- Ensure that the units stay free and clear of any taxation, seizure or right of retention, and pay the taxes and other government fees.

 In cases of functional or safety issues with rental units, discontinue their use and immediately inform Sanivac. Generally speaking, the customer understands and accepts that Sanivac will not be liable for any material damage caused to the rental equipment or services provided under this contract, or even related to the material or equipment used by Sanivac's employees as part of services provided under the terms of this contract, unless the damage was caused by Sanivac or its employees' gross negligence or willful misconduct.
- Return all equipment in the same condition as delivered, normal wear and tear excluded.
- Pay all costs for any repair, restoration, or replacement arising out of any event, such as loss, fire, theft, vandalism, disappearance, wind, or storm; as if they were read in costs for any repair, restoration, or replacement arising out of any event, such as loss, life, their, varidansin, disappearance, which, or storin, as if they were the insurer while the sanitary units are in their custody and possession throughout the rental period. In the event where the sanitary units are far too damaged to be repaired, the client will pay the replacement value to Sanivac. The customer consents to respect and comply with Sanivac's decision regarding the need to repair or not the equipment's damages.

 Take responsibility and cover any claim, penalty, and/or fine, including Sanivac's legal and professional fees incurred, as a result of any contravention and/or corporal and/or material damages arising from the possession, usage, or equipment's operation or content, except in the case of a manufacturing defect. The customer will be liable and will indemnify Sanivac for any claim, penalty, and/or fine, including professional and legal fees incurred.

 Pay the appearance will be liable and the investors and statements of accounts within the grand paried or paried or the date of investors failing.
